

# EXECUTIVE ORDER



## *City of New Mecca*

### UNITED STATES OF AMERICA REPUBLIC, CITY OF NEW MECCA, PROVINCE ILLINOIS

Pursuant to the United States of America Republic Constitution **Amendment 19, Section 2, Clause 2**, wherein it states; “ **The United States of America Republic** shall make all Laws which shall be necessary and proper for carrying into Execution the foregoing Powers, and all other Powers vested by this Constitution in the Government of the United States of America Republic, or any Department or Officer thereof”, there shall hereby be designated “**Executive Order 911: Abolishing Qualified Immunity for Government Officials Violating Constitutional Rights**” provisions to serve this purpose. This Executive Order shall go into immediate force.

**Introduced as Executive Order 911**, an Order was delivered by the President to Continental Congress of the United States of America Republic to honor and therefor to bring in full force **Executive Order 911**;

**The Executive Order 911** has now been entered into full force.

**The 1st Continental Congress** of the United States of America Republic now have 30 days to make delivery of said **Executive Order 911** to be posted for public notification. The document known as **Executive Order 911** was signed and enacted into law on January sixth 2025 by the President and reads as followed;

**Executive Order: Decolonization and Transition of Power to the Moorish American peoples of the Americas**

**WHEREAS**, the history of colonization in the Americas has resulted in the systematic displacement, disenfranchisement, and oppression of Indigenous peoples, undermining their sovereignty, culture, and rights;

**WHEREAS**, the United Nations Declaration on the Rights of Indigenous Peoples (UNDRIP) affirms the right of Indigenous peoples to self-determination, cultural preservation, and participation in decision-making that affects their lives;

**WHEREAS**, the International Covenant on Civil and Political Rights (ICCPR), to which the United States is a party, guarantees the rights of all peoples to freely determine their political status and pursue their economic, social, and cultural development;

**WHEREAS, the United States has failed to fully uphold the rights of Indigenous peoples, and it is necessary to acknowledge and remedy this historical injustice by facilitating the transfer of power to Indigenous governance structures;**

**WHEREAS, a national constitution created by the Indigenous peoples of the Americas has been established in accordance with international law, providing a foundation for self-governance, protection of human rights, and the realization of Indigenous sovereignty;**

**NOW, THEREFORE, by the authority vested in me as President of the United States, I hereby issue the following Executive Order:**

### **Section 1: Declaration of Decolonization and Transition of Power**

- 1. The United States federal government will initiate a comprehensive process of decolonization, transitioning political, economic, and administrative power to Indigenous peoples and their representative governing bodies, as set forth in the newly established National Constitution of the Indigenous peoples of the Americas.**
- 2. All executive, legislative, and judicial authority previously held by the federal government will be devolved to the newly established National Government of the Indigenous peoples, which shall be empowered to exercise the rights and responsibilities of self-governance in alignment with international legal frameworks, including the Covenant on Civil and Political Rights and the United Nations Declaration on the Rights of Indigenous Peoples.**

### **Section 2: Transition of Law and Governance**

- 1. The Indigenous National Government shall assume all responsibilities for the protection, promotion, and enforcement of Indigenous rights, including but not limited to the management of land, resources, cultural preservation, and self-determination.**
- 2. The federal government will work in cooperation with Indigenous authorities to ensure a peaceful and orderly transition, providing the necessary support and guidance for the implementation of the new governance system.**
- 3. Laws, regulations, and policies implemented by the federal government that are in conflict with the National Constitution and rights of Indigenous peoples will be repealed or amended as necessary to respect and recognize Indigenous sovereignty.**

### **Section 3: The Role of the National Guard**

- 1. The National Guard shall be tasked with safeguarding the security and rights of all citizens under the new National Government framework, including the prevention of domestic violence, abuse of power, and any actions that infringe upon the rights of Indigenous peoples.**
- 2. The National Guard shall be deployed to ensure the protection of Indigenous communities from violent threats, including any forms of domestic violence or brutality perpetrated by law enforcement, government agents, or other individuals.**
- 3. The National Guard will receive specialized training on respecting the sovereignty of Indigenous nations, human rights protections, and how to respond effectively to incidents of police violence, ensuring that such actions do not infringe upon the integrity of Indigenous governance.**

### **Section 4: International Recognition and Cooperation**

1. The United States will formally recognize the sovereignty of Indigenous nations and the National Government of the Indigenous peoples of the Americas as independent and legitimate under international law.
2. The United States will engage with the international community, including the United Nations, to ensure the peaceful recognition of this transition and the ongoing protection of Indigenous rights.
3. Diplomatic efforts will be made to ensure that Indigenous nations are represented in global forums, including the United Nations, as sovereign entities with the right to self-determination.

#### Section 5: Implementation and Oversight

1. An oversight committee will be established to monitor the progress of the transition and ensure that the decolonization process is carried out in good faith, transparently, and in accordance with Indigenous peoples' expectations.
2. The committee will report to the National Government of Indigenous peoples and the United Nations, ensuring that the transfer of power is completed effectively and that all actions comply with international law.
3. A comprehensive framework for reconciliation and reparations will be established to address the historical harms caused by colonial practices and to support the healing and restoration of Indigenous communities.

#### Section 6: Conclusion

This Executive Order affirms the commitment of the United States to the principles of justice, human rights, and Indigenous sovereignty. The transition of power to Indigenous peoples is a historic step toward rectifying the wrongs of colonization, protecting the rights of Indigenous communities, and ensuring a future of peace, equity, and self-determination for the nations of the Americas.
